## Streetscape Masterplan Goals

#### Develop a plan for the public right of way that addresses:

- Infrastructure improvement needs
- The safety and convenience of all users of the transportation system
- The pedestrian experience and sense of place
- Connectivity throughout the corridor
- Transit needs
- Sustainable best practices
- Long term maintenance



### Benefits of a Streetscape Masterplan

A streetscape masterplan is a prioritized and phased implementation document that outlines the proposed right of way improvements, including cost estimates, and potential funding sources.

### How does the plan get implemented?

- Federal, state, or city funding
- Leveraging public and private utility upgrades
- Leveraging private development



### What we Heard

#### Infrastructure Elements


Attendees were encouraged to consider the condition of the sidewalk, roadway pavement, stormwater and/or flooding concerns, roadway and pedestrian lighting, and other elements.

- Wider sidewalk requested on south side of 61st, east of Cottage Grove
- Increase roadway and pedestrian lighting throughout corridor
- Improve drainage and storm water management.
- Left turn signals at key intersections
- Mixed feedback on curb bumpouts
- Consistency requested in sidewalk widths and surfaces along 61st street
- Concern over losing residential, non-permit parking





### What we Heard

#### **Pedestrian Accessibility**

Attendees were encouraged to consider crosswalk locations, visibility of pedestrians within the crosswalks, curb ramps at intersections, and pedestrian signage.

- Slow down traffic
- Increase crosswalk accessibility, safety and visibility
- Improve lighting, signaling and surface reflectivity for crossings
- Mixed feedback on adding more stop signs





#### **Transit Accommodations**


Attendees were encouraged to consider CTA bus stop locations, bus stop benches and shelters, proximity to Metra stations, and signage.

### Transit Accommodations Analysis








# **Community Identity and Placemaking**

#### What we Heard

#### Community Identity/Placemaking

Attendees were encouraged to consider use of public space for placemaking elements such as public art and promoting Woodlawn community events.

- Incorporate community history into new and more durable neighborhood identifiers
- Commission local artists to make community focused public art
- Balance the divide between UofC campus and the community and make these boundaries more permeable
- Unite identities of east and west Woodlawn.
- Create "people spots" for residents to gather and relax along the right of way


