- 2. Approval of Minutes The meeting minutes from February 3, 2016 were approved
- 3. Pedestrian Crash/Fatality Update 14 fatalities year-to-date, down from 17 in 2015; average is 10.6
- **4. Vision Zero Focus Cities Update –** CDOT is collaborating with multiple City departments to develop the 3-year action plan; the Steering Committee has identified plan goals, and staff-level working groups are meeting to develop strategies to meet these goals.
- **5. Winter Wonder Awards and Snow Removal Update** for the 2015-2016 winter season, 7-10 inches of snow, 4 snow events, and 3654 customer service requests were unofficially reported. Winter Wonder Awards for the 2015-2016 winter season were presented to *My Block, My Hood, My City* and *La Cienaga*.

6. Connectivity Chapter Overview -

- Maintain Pedestrian Access During Construction: CDOT's *Rules* and *Regulations for Construction in the Public Way* were updated for 2016
- Improve Snow Removal Practices: Municipal Code of Chicago amendments took effect in November 2015
- Improve Underpasses: One Summer Chicago 2016
 Infrastructure Program painting throughout the City
- Improve Pedestrian Data Collection and Sharing Methods: Automated counter trials on the Bloomingdale Trail; pedestrian counts at high-crash locations

7. CLOCC's Neighborhood Walkability Initiative -

- Need to change the context to encourage healthier decisions and to make a larger impact.
- Begins with CLOCC's Neighborhood Walkability Assessment Tool (NWAT), based on Irvine Minnesota Inventory and others validated for research; Three parts: Assessing environment, facts and rights, and recommendations aligned with obstacles; prioritizes issues and develops action plan
- Sample questions include cars stopping at stop signs, pedestrian countdown timers, speed limits, empty lots.
- NWAT 2.0 will debut in 2016, incorporating crime and safety, e.g. "Does the current policing strategy make you feel safe?"
- Ongoing projects include UIC and El Valor in Pilsen, Enlace in Little Village
- Next steps: Kick-off event to introduce the revised tool in June;
 "Go-Live" for on-line repository for NWAT data;
 fundraising

8. Local Technical Assistance Projects and ON TO 2050

- LTAs implement GO TO 2040 by providing planning assistance to local communities
- Initiated in 2011; ~130 plans completed, 45 in progress
- Priority is given to lower-capacity communities

9. Public Comment

- O: Will Chicago consider "no turn on red" as a standard?
- A: Difficult to pilot city-wide, we may be able to pilot in specific locations. CDOT will follow-up
- Q: Is the LTA bike survey just about bike users?
- *A:* Yes, though the other surveys are broader.
- Q: How many pedestrian counters are out there?
- A: 50 are deployed in the downtown area; we will initiate a public input process for the others
- Q: Will the pedestrian count data be available in the Open Data Portal?
- A: Yes.

- New projects selected annually
- Examples: Green Healthy Neighborhoods Plan, Chinatown Community Vision Plan, Pilsen-Little Village Land Use Plan, UIC Multimodal Transportation Plan
